## • Presentation of "2021 Organization of the Year" to Troutman Fire and Rescue

Mayor Young recognized Troutman Fire and Rescue as the recipient of the Town of Troutman "2021 Organization of the Year" award expressing thanks and appreciation to Troutman Fire and Rescue for exemplifying true support, collaboration, integrity, and professionalism within our community not only by providing fire protection and medical services in efforts of minimalizing loss of life and property, but by sharing resources and facilities, participating in local events, and maintaining personal and professional relationships throughout the community. Fire Chief Wesley Morris and Assistant Fire Chief Jimmy Kestler accepted the 2021 Organization of the Year plaque, presented by Mayor Young.

Fire Chief Wesley Morris commented that Troutman Fire and Rescue is honored to receive the award thanking Council for their support and for the relationship between their organization and the Town of Troutman.

#### IV. STANDING REPORT(S):

#### • Troutman ABC Store Quarterly Report, (Layton Getsinger, ABC Board Chairman)

On behalf of the ABC Board, ABC Board Chairman Layton Getsinger, presented the report for the ABC Store's performance for the end of the 3rd Quarter (January - March 2020-2021) stating that while still robust, sales begin slightly tapering off in March in comparison to the corresponding quarter and month of the previous year. The store ended the 3rd Quarter at 14.32% above last year's 3rd Quarter.

Mr. Getsinger presented the following general highlights:

- As of the end of March we have generated net sales of \$7,724,149.35 since opening on 12/1/2016.
- The store surpassed \$2 Million in sales for this year on 4/17/21 and was on track for \$2.51 million in sales by the end of June.
- Since opening the store has generated \$481,119 in profits after distributions.

- As of March the store's distributions are \$184,557.17
  - . \$135,603 to the town, ESC Park, Library and Schools
  - . \$20,398 to Troutman Police Department
  - . \$28,557 to DACI for Alcohol and Drug Training

## 3rd Quarter highlights are as follows:

- 3rd Quarter Net Sales: \$562,259 14.3%↑ over 3rd Qtr. last year
- 3rd Quarter Operating Expenses averaged (before Distributions): \$25,323 per month
- A 15% increase over last year's 3rd Quarter of \$22,026
- · Increase in payroll, credit card processing fees, and liquor delivery fees were the major reasons for this increase.

## 3rd Quarter Net Profit (after distributions): \$34,667; 4% increase over 3rd Qtr. last year of \$33,295

- 3rd Qtr. Distributions: \$20,400
  - . Town, ESC Park, Library and Schools: \$16,075
  - . Law Enforcement \$1,802
  - . Alcohol/Drug Education (DACI): \$2,523
- Retained Working Capital at the end of Qtr. is \$393,109.
- Maximum allowed: \$414,071

The store currently has \$300,009 in savings.

#### Forecast:

- Revenues in March and April were each 4% below last March and April
- Budgeted Revenue for this FY (2020—2021) is: \$1,742,824:
- Revised Forecast based on our 3rd Quarter sales is currently:
- . \$2.51 million, a 44% increase over budget
- Budgeted Profit is \$148,220 before distributions
- Budgeted Distributions are: \$67,664
- The store is on a profit trajectory (based on 3rd Quarter performance of \$240,000 before distributions) which
  would be approximately \$110,000 and is at full staff with no known needs to add additional payroll outside of
  our typical pay increases for the coming year.

Mr. Getsinger responded to a question regarding expansion South of Town stating that the Board has been looking at locations and due to land becoming more expensive each day, action will soon need to be taken. He commented that he is hoping to be under construction with a second store in about two (2) years assuming they purchase the land and build verses renting.

Mayor Young expressed appreciation to Mr. Getsinger, General Manager Evelyn Walls and the ABC Store Staff for a job well done.

# \*\*ITEM 13. Consider Approval of a Troutman Elementary School Resource Officer Full-time Position, (Wyatt)

Town Manager Wyatt informed Council that Iredell Statesville Schools (ISS) have approved a full time position for a School Resource Officer (SRO) for Troutman Elementary that includes ISS paying 10 months of the SRO's salary leaving the Town to pay the remaining 2 months' salary.

Councilmember Eddie Nau thanked the School Board for providing the additional SRO that the children's safety is the utmost concern. He expressed appreciation for the School Board's vision and to the Troutman Police Department in filling the position.

Mayor Young asked that Council's appreciation is conveyed to the School Board.

Upon motion by Councilmember Eddie Nau, seconded by Councilmember George Harris, and unanimously carried, approved the additional position of a full-time SRO.

#### VII. ELECTED OFFICIALS / STAFF REPORTS AND COMMENTS

#### Town Council

Councilmember George Harris

- . Recommended that everyone get his or her COVID vaccine so that the mask requirement can go away.
- . Suggested that the Town Manager may want to take a ride to Kannapolis to see what they did with their downtown during their revitalization project.

. Voiced concern of speeding at the corner of Thomas and Wagner for safety regarding the crosswalk at the same location stating that cars are not stopping for kids going to the middle school.

#### Councilmember Eddie Nau

- Congratulated everyone graduating from college and high school along with expressing appreciation to all teachers.
- . Thanked Lt. Darrin Payne for doing a great job filling in as Interim Police Chief.
- Asked that Interim Chief Payne congratulate Officer Madison Sharpe on the great job he is doing in the community.

## Councilmember Sally Williams

- . In recognition of National Police Week appreciation was expressed for the great job the Police Department is doing commenting that it is a reflection of Interim Chief Payne's leadership.
- . Voiced that sandwich signs are left out by businesses overnight when they are supposed to be taken up daily at closing. Manager Wyatt responded that the issue has been addressed with Code Enforcement.
- . Thanked Parks & Rec. Director Emily Watson for visiting the sites where Farmer's Market vendors get their product making sure they are not selling retailed products.
- . Thanked all staff for going the extra mile doing more than what their job description calls for expressing appreciation to Paxton Hix in taking pride for what he does for the Town.

#### Councilmember Henkel

Expressed security concerns regarding IT requesting that staff be pro-active in taking measures to keep the Town secure. Mayor Young and all other Council members were in agreement. Town Manager Wyatt stated that his concerns are duly noted and he will address and take seriously.

### **Mayor Young**

- Expressed appreciation to all involved in the beautification of the Town including the repaving of the parking lot
- . Asked for continued prayers for the family of Officer Sheldon who was killed in the line of duty.
- . Congratulated and expressed appreciation to Interim Planning Director Jonathan Wells for his service to the community and recognition in fixing up bikes for a program called "Bike Share". Mr. Wells thanked the Mayor commenting it is a unique and humbling experience. He informed Council that local TV stations are scheduled to do a story on the program calling it "Bikes for Neighbors".

## Town Manager

- . Commented on the current paving of the parking lot apologizing that the paving happened during a Council meeting week.
- . Shared accolades from the Iredell-Statesville School Board Chairman Martin Page thanking and praising Troutman Police Officers for their presence at the last school board meeting stating the officers acted respectful, responsively and professionally.
- In recognition of National Law Enforcement Memorial Week, Town Manager Wyatt recognized Troutman Officer William (Bill) John Pettit who passed away in the line of duty. Mayor Young stated that he appreciates Manager Wyatt's comments of Officer Pettit and he is looking forward to possibly having his family here for a formal recognition.
