# Iredell County Appraisals

The reappraisal process is a highly prescribed process that is required by law and regulated through the North Carolina Department of Revenue. Iredell County is required to perform a reappraisal every eight years; However, it is recommended that we perform it every four years, which is Iredell County's practice. This new value should accurately reflect your home's current fair market value as of January 1, 2023. This value is being compared to four years ago as opposed to last year. With that said, real estate's value has grown exponentially over the past four years. The below chart depicts the steady increase in the **median sales prices** of residential homes in Iredell County from the first quarter of 2019 through the fourth quarter of 2022, which is a 60% increase.

As Town of Troutman residents, the Council and many staff also pay taxes based upon reevaluation. We have and will continue to look for ways to offer citizen services and amenities at the lowest tax rate possible. We have projects in our future, such as a new Town Hall, the current Town Hall remodeled to be the police department, new amenities in our current park, new pocket parks, repaving of subpar streets, and of course, continuing to keep our infrastructure updated (to not lose fresh water coming in or allow rainwater to access our sewer system going out - which costs us to process as if it were sewage). These items are costly, and we have been saving to accomplish them. It would not make sound economic sense to reduce taxes because of accurate appraisals to turn around in a couple of years and raise taxes higher than the current rate to pay the new loans required for the before-mentioned items. I promise you we will talk about items publicly as the Town Council and staff do every year. If it makes sense to make a tax adjustment lower, we will be happy to do so. As stated previously, we pay the same rate as you. Thank You.



### Planning Dept: Development Decisions

Have you ever wondered how developments are approved in the Town of Troutman? Well, before the shovels hit the ground, rezoning development proposals must go through the following review and decision-making process:

Application and TRC Review: When a developer has identified property, they are interested in developing, it is typical that a change in zoning is required. To start the process, an application for conditional zoning (CZ) is submitted to the Troutman Planning Department. An application requirement is that a concept plan showing how the applicant intends to develop the property must be submitted. The concept plan is reviewed by the Towns Technical Review Committee (TRC) which is made up of town and county planning staff, the town engineer, the fire marshal's office, NCDOT, and Iredell Statesville Schools. These agencies review the proposed plan and provide comments that will be used in making a decision on the requested rezoning.

Community Meeting: With all conditional zoning applications, a Community Meeting is required. This is a meeting hosted by the applicant, and is typically held at Town Hall. Community members are invited to hear the developer's proposal, view their plan, and ask questions. The applicant is required to provide a community meeting report outlining the questions asked and concerns raised at the meeting. A copy of this report is provided to the Planning Board and Town Council and is used to make a decision on the requested rezoning.

Planning Board Meeting: The Planning Board is an appointed board charged with reviewing development proposals and making recommendations on development proposals that are forwarded onto Town Council. The Planning Board is provided the applicant's concept plan, and all other required materials, as well as a staff report outlining the proposal and how it fits with adopted town plans including our Land Use Plan, Pedestrian Plan and Transportation Plans. During this meeting, the staff and applicant make presentation, the public is invited to speak, and the Board asks questions of the developer and staff prior to making their recommendation.

Town Council Public Hearing: Town Council has been elected by the Town to repent its citizens in making many decisions, including rezonings that effect the development pattern of the Town. The Council uses information forwarded by staff as well as residents and other local agencies to make decisions that are in the best interest of the entire Town.

<u>Permitting Review</u>: After the Town Council has agreed to approve a request for rezoning the permitting review process begins. This involves ensuring that all applicable Town, County and State requirements are adhered too. Once all plans have been reviewed and approved then permits are issued allowing development to begin.
